## **Resolution in Support of the Fair Elections Now Act**

**WHEREAS** elections should be about voters, not about big money campaign donors,  
and

**WHEREAS** members of the United States Congress should be accountable to voters,  
and not to the wealthy special interests who give large campaign contributions,  
and

**WHEREAS** a system of public financing of elections, or RFair ElectionsS is a  
proven, practical way to allow candidates to seek office without courting  
special interest money, to effectively counter the influence of money on our  
elections, and to govern more effectively once elected, now

**THEREFORE BE IT RESOLVED** that the Claremont Democratic Club endorses the Fair  
Elections Now Act, introduced in the 111th Congress by Senators Richard Durbin  
(D-Ill.) and Arlen Specter (D-Pa.) and Representatives John Larson (D-Conn.)  
and Walter Jones (R-N.C.) to provide a system of public financing for  
congressional races, and

**BE IT FURTHER RESOLVED** that the Claremont Democratic Club urges the United

**Steele: Oops, he did it again.**

**Sorry, Republicans-you're stuck with Michael Steele, said Marc Ambinder in the Atlantic.com. The tone-deaf Republican National Committee chairman had perhaps his most horrible week yet last week, after revelations that the RNC had picked up a \$2,000 tab for a group of young donors who were entertained at a lesbian-bondage-themed nightclub in West Hollywood. Steele wasn't at the club and didn't approve the expenses. But the embarrassing lesbian bondage" story broke at the same time that some Republicans Were grumbling about Steele's flamboyant spending of party dollars on his own comforts-\$12,000 on limousines and \$17,000 on private planes in a single month. Steele spent another \$18,000 to decorate his office. To fire Steele, though, would take a two thirds vote of the RNC's members, and there's no way that'll happen. "Republicans don't want to be stuck with the symbolism of having rejected their first elected black chairman."**

While being interviewed on ABC, Steele seemed to defend President Obama by saying that both he and the president are lightning rods for criticism because they're black. "Barack Obama has a slimmer margin" because he's the first black president, Steele said. "It's a different role for me to play and others to play and that's just the reality of it." The guy is "loose cannon" said Cynthia Tucker in The Atlanta Journal-Constitution. And he just can't stop drawing attention to himself. Let's face it: "Michael Steele is an affirmative action gone badly." He'd be fired tomorrow. "If the Republican Party weren't so self conscious about its lack of diversity."

**Race: Obama opts for "black"**

"It is official," said Sam Roberts and Peter Baker in the New York Times. "Barack Obama is the nation's first black president." The White House confirmed that the president had checked "Black, African-Am., or Negro" when filling out his 2010 census questionnaire. The form provides "more than a dozen options" for race, and given Obama's mixed parentage-he's the son of a white woman from Kansas and a black man from Kenya-he could have checked white; both black and white or the final category, "some other race," which can then be specified in writing. The form contains no specific category for mixed race, but Americans have been permitted to check more than one box since 2000, when about 6.8 million people reported being of two or more races. Obama, however, bypassed that option, staking his claim squarely on his father's heritage.

Obama is unmistakably a black man. By making it official, he merely shows he's "comfortable with who he is." What choice did he have? Said Earl Ofari Hutchinson in OpEd News.com, "In America, where a single drop of black blood once relegated citizens to second-class status, we are still defined, first and foremost, by our skin color. Not even a president is "exempt from racial loathing." As witnessed by the Confederate flags at Tea Party protests and the "ape and monkey depictions" of president and First Lady on websites. If Obama had tried to identify himself as biracial, neither whites nor blacks would have believed him.

The number of interracial marriages has soared 300 percent over the past decade, and one in 13 marriages now unites people of different races. In the coming years, the "social contract" of race will be transformed to the point that it no longer fits inside a neat little box.
